

# FOCUS Investment Banking Combines Three Tire Businesses into One and Sells it to Big Brand Tire

### PROCESS & OVERVIEW

Phoenix, Arizona is one of the fastest-growing markets in the country and several national acquirers had already completed transactions in the area when FOCUS was engaged by Community Tire (6 locations) and S&S Tire (3 locations) to sell their businesses. The problem that arises in these cases is that existing acquirers want to 'cherry-pick' the best locations that don't conflict with their existing stores instead of acquiring them all. This is a non-starter for any tire dealer looking to exit. The best option is to find acquirers not already in the market, but these acquirers need at least 10 locations to make it worth their time and energy to enter a new market.

By engaging with a third company in Phoenix, C&R Tire (5 locations), FOCUS was able to assemble a 14-store group comprising \$30 million in revenue (and 10% EBITDA), combine it 'on paper' (identifying cost savings and synergies) and market it as it were a stand-alone company -instead of three smaller companies. The advantage for the sellers is that they were able to share a higher valuation based on the larger size of the combined entity- a far better outcome than they could have achieved individually. The advantage for the buyer was acquiring a footprint that made them a significant competitor in the market from day one.

### TRANSACTION RESULTS

The deals, comprising 14 locations, closed in mid-December 2021. They boosted Big Brand's store count to over 165 outlets in Arizona, California and Colorado.
